Ms. No. 7/2004/Wel (SW-V), dated 12-2-2004 of the Chief Secretariat (Welfare) (hereinafter referred to as the said rules) namely :—

## AMENDMENT

In the said rules, in sub-rule (a) of rule 4, the following shall be substituted namely :—

**"4. Eligibility :**

(a) The annual income of the applicant or his parent/guardian should not be more than ₹ 75,000 per annum. The income of the parent/guardian will be taken into account only in cases where the applicant is dependent on the parent/guardian and he has no other source of income."

The Lieutenant-Governor, Puducherry is pleased to enhance the income ceiling limit of families belonging to Economically Weaker Sections (EWS) from ₹ 24,000 to ₹ 75,000 for availing grant of financial assistance/incentives and for the said purpose, hereby makes the following amendment to the "Rules for Admission of Students in Government Hostels for Backward Classes run by the Directorate of Social Welfare, Puducherry" notified in G.O. Ms. No. 4/2009-Wel (SCW), dated 2-3-2009 of the Chief Secretariat (Welfare) and published in the Gazette of Puducherry *vide* No. 8, dated 10-3-2009 (hereinafter referred to as the said rules) namely :—

## AMENDMENT

In the said rules, in sub-rule (a) of rule 3, the following shall be substituted namely :—

"3. The annual income of the parents or guardian of the students for admission to these hostels should not exceed ₹ 75,000 :

Provided that selection of boarders will be made in such a way that a student whose parent's / guardian's income is less, gets preference over the student whose parent's/guardian's income is more."

2. This issues with the concurrence of the Finance Department *vide* their U.O. No. 3549/F5/A2, dated 5-3-2015.

3. This amendment shall be deemed to have come into force with effect from 8-9-2014.
