NOTIFICATION

The Lieutenant-Governor, Puducherry is pleased to remove the income ceiling in respect of mentally challenged persons for the grant of financial assistance to the disabled persons in the Union territory of Puducherry and for the said purpose, hereby makes the following further amendments to the "Financial Assistance to Disabled Persons Rules, 1992", issued *vide* G. O. Ms. No. 19/93-Wel(SW-I), dated the 6th April 1993 and published in the Part-II of the Extraordinary Gazette No. 12, dated 20th April 1993, namely:—

AMENDMENT

- 1. Short title and commencement.— (1) These rules may be called the Financial Assistance to Disabled Persons (Amendment) Rules, 2007.
- (2) They shall come into force on and from the date of their publication in the official gazette.
- 2. Amendment to rule 4.— For clause (iii) under rule 4 of the Financial Assistance to Disabled Persons Rules, 1992, the following clause shall be substituted, namely:—
 - "(iii) the income of the disabled and his parents should not exceed Rs. 35,000 per year :

Provided that the provisions of this clause shall not apply to mentally challenged persons within the meaning of clause (i) and clause (1) of rule 2 of these rules; and".
