NOTIFICATION

Whereas, in the (i) G.O. Ms. No. 9/2001-Wel. (SW-II), dated 19-2-2001; (ii) G.O. Ms. No. 13/2002-Wel. (SW-II), dated 12-3-2002; (iii) G.O. Ms. No. 26/2002-Wel. (SW-II), dated 10-6-2002; (iv) G.O. Ms. No. 56/2003-Wel. (SW-V), dated 1-12-2003; (v) G.O. Ms. No. 42/2004-Wel. (SW-V), dated 9-11-2004; (vi) G.O. Ms. No. 40/2005-Wel. (SW-V), dated 28-9-2005 and (vii) G.O. Ms. No. 19/2007-Wel. (SW-V), dated 19-6-2007 of the Chief Secretariat (Welfare), Puducherry, 67 castes/communities were notified as “Other Backward Classes” in the Union territory of Puducherry, based on the recommendations of the State Level Commission for Backward Classes, Puducherry with the approval of the Lieutenant-Governor, Puducherry;

And whereas, the State Level Commission for Backward Classes, Puducherry after examination of the claim have recommended in the Report No. 44 that in the list of the “Other Backward Classes”, the caste “Telikula/Telukula” shall be included;

Now, therefore, the Lieutenant-Governor, Puducherry, is pleased to accept the abovesaid recommendations of the Commission and to issue the following further addendum to the Government Order cited above namely:—

ADDENDUM

In the Annexure to the G.O.Ms.No. 9/2001-Wel. (SW-II), dated 19-2-2001 of the Chief Secretariat (Welfare), Puducherry—

(i) after Serial No. 67 and the entries relating thereto, the following shall be included, namely:—

68. “Telikula/Telukula”
